Your rights

Right to lawful and secure processing of your personal data

BelgiumSurgeryServices always processes your personal data with due care. This includes the following:

- your personal data are processed in accordance with the justified purposes described in this privacy statement.
- your personal data are only processed in so far this is necessary and relevant, nor too excessive.
- your personal data are only saved for as long as necessary to achieve the purposes as specified in this privacy statement.

We have adopted the necessary technical measures to limit the risks of unlawful access to your personal data, or the processing thereof, to a minimum. In the event the IT systems are hacked BelgiumSurgeryServices shall immediately adopt all possible measures to limit the damage to a minimum.

Right of access, rectification and erasure of personal data

After providing proof of your identity, you have the right to find out from BelgiumSurgeryServices whether your data are processed. If your data are in our files you have a right of access to the collected personal data. If you want to use your right of access, BelgiumSurgeryServices shall comply within one month after receiving the request. The request can be made either by registered post or by e-mail to info@belgiumsurgeryservices.com.

Incomplete or wrong data can always be rectified. It is up to the visitor to primarily adapt incomplete or wrong data himself/herself. You can exercise your right to rectification by contacting us. BelgiumSurgeryServices shall change your personal data at the latest one (1) month after your request.

Moreover, you have the right to have your personal data erased by us within a reasonable period of time. However, the "right to be forgotten" is only possible in the following cases:

- when the personal data are no longer necessary in relation to the purposes for which they were originally collected.
- when there is no other legal ground for the processing and the personal data were collected with consent.

- when you object to the processing of your personal data and there are no overriding legitimate grounds to save your existence. "Legitimate grounds" includes accounting and other legal obligations.
- when the personal data have been unlawfully obtained.
- when the personal data have to be erased for compliance with a legal obligation.

BelgiumSurgeryServices decides itself whether one of the aforementioned conditions has been met.

Right to object against and the right to restriction of the processing of your personal data.

You have the right to obtain a restriction of the processing of your personal data:

- during the period required for BelgiumSurgeryServices to verify the accuracy of your personal data in the event of a dispute.
- when the personal data are obtained unlawfully and you oppose the erasure of the personal data and request the restriction of their use instead.
- when the user's personal data are no longer necessary for the purposes of the processing and the user needs the personal data for the establishment, exercise or defence of legal claims.
- during the period required for BelgiumSurgeryServices to verify whether all conditions have been met to erase the personal data.

At all times you have the right to object against the processing of the personal data. BelgiumSurgeryServices shall suspend the processing of your personal data, unless BelgiumSurgeryServices demonstrates compelling legitimate grounds for the processing of the personal data which override the right to object.

You can exercise your right to object by contacting us. BelgiumSurgeryServices shall change your personal data at the latest one (1) month after your request. The request can be made either by registered post or by e-mail to info@belgiumsurgeryservices.com.

Right to data portability

As visitor you have the right to receive the personal data you provided to BelgiumSurgeryServices in a structured and machine-readable format. Furthermore, you have the right to transmit the data to another data controller if the processing solely depends on the user's consent.

Right to withdraw your consent for the processing and the right to lodge a complaint

At all times you have the right to withdraw your consent for the processing of your data. However, this changes nothing to the lawfulness of the processing based on the consent before the withdrawal.
